Memberships are non-refundable and non-transferable. Hiawatha cart riding passes purchased for the use of Hiawatha golf cars ARE GOOD FOR ONE HALF THE CART RENTAL! There is a two cart per foursome maximum for a Hiawatha leased cart unless special medical exceptions warrant additional carts per foursome. Hiawatha Private Golf Cart Policy: Cart shed fee includes your private trail fee for the primary cart owner and any immediate family members living at home. Private cart trail fees do not cover the use of Hiawatha owned golf carts. When using the a Hiawatha Golf Cart, private trail fee members must pay the discounted Hiawatha cart fees as set forth by the yearly fee schedule. Any other person that uses your private cart or rides with the primary cart owner, pays a \$9 trail fee to Hiawatha Golf Club. Those that purchase a Hiawatha cart riding pass , a trail pass , or are the primary cart owner of a cart in a shed do not have to pay the \$9 private trail fee when riding with a private cart owner.
